

## **eGamingFund Privacy Policy**

### **General Information**

GAMEFUND.PTE.LTD, located at 10 Anson Road, 13-15 International Plaza, Singapore 079903 ("The Company", "we" or "us") is the operator of this website, together with [egamingfund.org/bloglist](http://egamingfund.org/bloglist) (each a "website" and together, our "websites"). As the operator of the sites, we take the protection of personal data very seriously. We collect, process and use your personal data in accordance with this privacy policy and in compliance with the General Data Protection Regulation ("GDPR").

This privacy policy ("Privacy Policy") will provide you with information about the collection, processing and use of your personal data when using our websites.

### **Visiting our Websites**

When you visit our Website, the hosting provider of our website, GitHub Pages automatically collects and stores information in server log files that your browser transmits to us. The information/data mentioned is neither assigned to specific persons nor linked to data from other sources. The following technical data will be recorded by us, as usual with every connection with a web server, without your intervention, and stored by us until automatic deletion after no later than two days:

### **Use of Websites Cookies**

The Website uses cookies. Cookies are text files that are stored in a computer system via an Internet browser. More detailed information on cookies and how they work can be found at: <http://www.allaboutcookies.org>.

Many Internet sites and servers use cookies. Many cookies contain a so-called cookie ID. A cookie ID is a unique identifier of the cookie. It consists of a character string through which Internet pages and servers can be assigned to the specific Internet browser in which the cookie was stored. This allows visited Internet sites and servers to differentiate the individual browser of the data subject from other Internet browsers that contain other cookies. A specific Internet browser can be recognized and identified using the unique cookie ID.

Through the use of cookies, we can provide the users of this website with more user-friendly services that would not be possible without the cookie setting.

Cookies allow us to recognize our websites users. The purpose of this recognition is to make it easier for users to utilize our websites. The website user that uses cookies, e.g. does not have to enter access data each time the website is accessed, because this is taken over by the website, and the cookie is thus stored on the user's computer system.

You may, at any time, prevent the setting of cookies through our websites by means of a corresponding setting of the Internet browser used, and may thus permanently deny the setting of cookies. Furthermore, previously set cookies may be deleted at any time via an Internet browser or other software programs. This is possible in all popular Internet browsers. If the data subject deactivates the setting of cookies in the Internet browser used, it may not be possible to use all the functions of our websites.

### **Google Analytics**

This website also uses Google Analytics, a web analysis service provided by Google Inc. ("Google"). Google Inc. is an enterprise of the holding company Alphabet Inc., domiciled in the USA. The information generated by the cookie about your use of the websites (including your IP address) will be transmitted to and stored by Google on servers in the United States. Google will use this information for the purpose of evaluating your use of the website, compiling reports on websites activity and providing other services relating to websites activity and internet usage. Google may also transfer this information to third parties if this is required by law or if third parties process this data on behalf of Google.

Generally, before the data is transmitted to the provider, the IP address will be abbreviated by activating IP anonymization (anonymizeIP) on this website, within the member states of the European Union or in other contracting states of the agreement on the European Economic Area. In these cases, we provide contractual guarantees to ensure that Google Inc. maintains a sufficient level of data protection. We do not use the information and personal data collected by Google Analytics to identify individuals unless we become aware of specific indications of illegal use.

### **Social Media**

We use plug-ins from social networks such as GitHub, Discord, YouTube, Reddit, Twitter, Facebook, LinkedIn on our websites. When you activate them (by clicking on them), the operators of the respective social networks may record that you are on our websites and may use this information. This processing of your personal data lies in the responsibility of these individual social media platforms according to their privacy policy. Please check with these individual social media platforms regarding their privacy policies. eGamingFund is not responsible for data collected by these individual social media platforms. We only use these platforms to inform our community of updates and answer user questions.

### **Third Parties**

With the exception of the provider of our website, we do not make your personal data available to third parties unless you have expressly consented to it, if we are legally obligated to, or if this is necessary to enforce our rights concerning a contractual relationship.

The Website service provider to whom the personal data collected via the Websites is passed on is GitHub Pages. The Websites are hosted on servers in various locations but mainly in the regions of the USA and Australia. The transfer of data is for purpose of providing and maintaining the functionality of our websites.

### **International transfer of personal data**

Personal data collected on the Website may be stored and processed in any country in which we or our affiliates, suppliers, subsidiaries or agents maintain facilities, and by using the Website, you consent to any transfer of information outside of your country (including countries which may not have been assessed as having adequate privacy laws). Nevertheless, we take steps to ensure that our affiliates, agents, subsidiaries and suppliers comply with our standards of privacy regardless of their location.

They are obliged to protect data privacy to the same extent as we ourselves. If the level of data protection in a given country does not correspond to the European data protection level, we contractually ensure that the protection of your personal data corresponds to that in the EU at all times by concluding agreements using the standard contractual clauses and complying with the GDPR.

### **Data security**

We use appropriate technical and organizational security measures to protect your stored personal data against manipulation, partial or complete loss, and unauthorized access by third parties. Our security measures are continuously being improved in line with technical developments.

Please note that any data transmission on the Internet (e.g. communication by e-mail) is generally not secure and we accept no liability for data transmitted to us via the Internet. Unfortunately, absolute protection is not technically possible.

This information does not apply to the websites of third parties and the corresponding links given on our websites. The Company assumes no responsibility and liability for these.

### **Your Rights regarding your data**

The User has the right to:

- request access to personal data
- request correction of personal data
- withdraw the consent to the processing of data (e.g. for marketing activities)
- request deletion of personal data
- receive data in a structured, commonly used and machine-readable format (data portability)
- request the restriction of processing personal data
- to object to the processing of personal data
